
Other terms and conditions

1. The rates quoted above shall remain valid for four months from the date of opening for the tender after approval the rates quoted will remain valid for Two Kisan Mela organized twice in a year.
2. All materials to be supplied by the contractor should be of superior quality. Materials approved by the University shall only be allowed for use at site on F.O.R. Pantnagar.
3. Wide variation in above quantities may occur on either side. No claim, what so ever shall be entertained.
4. Income tax and sales tax, if any as per G.O. shall be deducted at source from the bill of the contractor. The other applicable taxes, such as GST, Service Tax etc are to be borne by the contractor giving TIN No., GST No. Service Tax registration No.
5. The pandals in the Mela ground must be ready only one day earlier than the start of the Kisan Mela in all respect.
6. The responsibility of the safe type of the hired material against, fire, theft, riots and other unforeseen hazards shall be of the contractor and not of the University.
7. The accepting authority shall have the right of rejecting all or any of the tenders without giving any reasons or explanation.
8. Payment will be made on receipt of bill duly signed by the contractor after completion of the work/Mela.
9. No other payment shall be made to the contractor except mentioned in the agreement.
10. Negotiations can be made by the undersigned/authorized committee, if required from lowest quoted firm.

11. You will have to deposit 25,000.00 only (Rs. Twenty Five Thousand Only) by you as earnest money in the form of demand draft or fixed deposit receipt or bankers cheque or bank gurantee in favour of Comptroller G.B. Pant University of Agriculture & Techno0logy, payable at SBI/PNB/UCo/Union Bank, Pantnagar.
12. In the event of work order, contractor has to signed an agreement with University on two no-judicial stamp paper of Rs.100.00 each, which shall be purchased by the contractor.

14. If the tender documents downloaded from the Univ. website by the firm then following certificate should also be Signed by the tender.
