

SHORT TERM TENDER NOTICE

Sealed tenders are invited from Public Sector undertaking Insurance Companies approved by IRDA of India, regarding Group Health and Personal accident insurance policy for all the bonafide students of G.B.Pant University Ag. & Technology, Pantnagar for the year 2017-18. Interested insurers are advised to submit their Tender vide registered/speed post only on or before **01.08.2017 upto 5:00 PM**. Presently there are about 4800 registered students in the University studying in various degree programmes.

Main terms & conditions of tender notice regarding Medical Insurance Policy are as follows:

1. Risk of accidental death or permanent disability of a student for a sum insured upto Rs. 2,00,000/-
2. Risk of accidental death or permanent disability of parents/guardian of student for a sum insured of Rs. 2,00,000/-. Further the student shall be reimbursed tuition fee, development expenses, boarding and lodging and other insured expenses for the remaining period of study upto Rs. 1,00,000/-.
3. Reimbursement of hospitalization/ domiciliary hospitalization expenses as indoor patient following sickness or injury without any sublimit upto Rs. 1,00,000/- in mediclaim section of the policy.
4. Premium rates must be quoted per student for premium and taxes separately.
5. Pre-existing diseases should be covered under Insurance.
6. Valid Photo Identity cards of University Bonafide student should serve as proof for completing necessary formalities in this regard.

7. Cashless facility to students for medical treatment by empanelled hospitals of insurer has to be given. Written consent of such hospitals for cashless facility should be provided along with the bid.
8. Claim intimation and claim submission period under mediclaim section must be at least for 7 days and 30 days, respectively.
9. Pre & post hospitalization period of treatment for claim settlement will be of 30 days and 60 days, respectively.
10. List of all empanelled hospitals authorized for treatment in Pantnagar jurisdiction and all over India should be submitted along with the bid.
11. Also quote your experience and issuance of such policies in past to a large institution like ours.
12. The right to accept or reject the tenders without assigning any reason will be reserved with the university.
13. The Insurance policy can be extended for a further period of one year on satisfactory service provided by the insurance company.
14. Any dispute arising in the process of the tender, the matter shall be referred to the Sole Arbitrator, who in such cases shall be Vice-Chancellor, G.B.Pant University of Ag. & Technology, Pantnagar and whose verdict shall be binding on the both the parties.
