All Deans/ Director Training and Placement/ HoDs,

Bureau of Indian Standards (BIS), the National Standards Body of India, seeks to engage students (stipend @ Rs. 20,000/ month) of prescribed disciplines (see the attachment) enrolled in recognized University/Institution within India. Students of GBPUAT (being MoU partner University of BIS) are elligible to apply provided he/she fulfils requited eligibility criteria. As "Interns", selected students would be given exposure to various activities of the Bureau. The Interns would be expected to supplement the knowledge capital of BIS through collection, collation and analysis of data in respect of standardization, conformity assessment and testing as well as consumer engagement and stakeholder expectations. For the "Interns", the exposure to the functioning of BIS and understanding of quality ecosystem, which would be an add-on in furthering their own career goals in the Industries, or International Organizations as well as Standards Bodies in India and abroad.

- 2. In this regard, please see the revised BIS Internship Scheme containing all detailed information, copy of which is attached herewith. Presently, applications are being sought for 6-month internship from January–June 2025, to engage students in the:
  - Standardization departments- Located in New Delhi
  - Certification Branch Offices of BIS located at 36 locations Please see Annexure III
  - 8 BIS laboratories located across India: please see Annex IV
- 3. Interested students meeting the prescribed criteria, may send the application in the following proformas and undertakings (enclosed) which shall be duly filled in and signed:
  - Application proforma; Appendix C
  - Acceptance of Terms and Conditions of Internship; Annexure I and
  - Undertaking by the Institute/University. Annexure II
- 4. Kindly note that BIS will try to accommodate students location preferences as much as possible, it may not always be feasible. In such cases, students may be offered different locations.
- 5. Non availability of interns for the complete six-month period, i.e. from Jan June 2025 may result in non-completion of internship.
- 6. It may be noted that incomplete applications are liable to be rejected.
- 7. Students whose applications had been received previously for internship but were not considered, may also send their applications for internship if they so desire.
