
The case was reported by the Warden, Nehru Bhawan duly forwarded by Dean V.A.Sc./Chief Warden and the case was put up in Student Discipline Committee. The Student Discipline Committee met on 16.04.2024 and thoroughly investigated the case in detail and based on the observations the committee came to conclusion that the above students were involved in the act of indiscipline as mentioned in the Academic Regulation of Chapter-III para 47 (1): (r) & (s).

After detailed deliberations, the committee members were of the opinion that the incident caused by all the above students Mr. Yashraj Pratap Singh, 59918, Mr. Rachit Soliyan, 61014, Mr. Atul Pranay, 59797, Mr. Ujjawal Tiwari, 59881, Mr. Pranjal Chaudhary, 60009, Mr. Trailokya Mohan Joshi, 60969 of College of Agriculture and Mr. Rajneesh Kumar, 60956 & Mr. Ritesh Kumar Ranjan, 61138 is of serious nature and all these students were involved in the act of indiscipline thus, recommended the following punishment as per academic regulation of Chapter-III 47 (2) (iii): (a) & (c).

- i. Fine upto Rs. 250/-. This shall be noted on the inmate's permanent record card but shall not go out on the transcript.
- ii. Severe Warning that one more act of indiscipline in future lead to serious punishment.

Keeping in view, the recommendations of the Student Discipline Committee and perusal of the records, the Vice-Chancellor has approved the recommendations of the Student Discipline Committee and awarded the following punishment to the above students under clause para 47 (2) (iii): (a) & (c).

- i. Fine of Rs. 250/-. This shall be noted on the inmate's permanent record card but shall not go out on the transcript.
- ii. Severe Warning that one more act of indiscipline in future lead to serious punishment.
