At the outset the Hon'ble Vice-Chancellor welcomed all the UMC members.

The following were discussed:

**Agenda-1 : Reopening of the University.**

Hon'ble Vice-Chancellor desired that the university should reopen as per Govt. guidelines/ SOP's. Cleanliness/ sanitation of hostels to be undertaken at the earliest.

**Action: (DWP/DSW)**

Registrar informed the house that request to reopen colleges have been received from Dean, Fisheries, Dean, Agriculture, Dean, CVASc. and Dean, HSc.

It was decided that the university should open in a phased manner.

1. Phase-1 :- Students of college of Fisheries, Agriculture, Veterinary & Home Science be called by 15<sup>th</sup> February 2021. Hostels under Dean, PGS to be ready for students in first phase.
2. Phase- 2 :- Students of College of Technology be called as and when dean concerned deems it fit. (keeping in view readiness of hostels).
3. Phase-3 :- All other students be called by 18<sup>th</sup> March 2021.

**Agenda-2 : Wages of Labourers.**

Hon'ble Vice-Chancellor desired that the wages of labourers should be disbursed in time. Collective efforts should be made in this regard. A meeting of comptroller, ADLW and Contractors should be convened with the Hon'ble Vice-Chancellor at the earliest to formulate a procedure for timely disbursal of wages.

**Action: (ADLW)**

**Agenda-3 : Estate/University property issues.**

Hon'ble Vice-Chancellor informed the house that as per act of the university, the comptroller is the custodian of the estate/university property. Revenue records are not properly managed and there is need to appoint a revenue officer. Meeting of the concerned officers in this regard be called at the earliest.


