

- 3- It was decided to take up cases of CAS for university teachers at the earliest.
(Action: CPO)
- 4- It was also decided to fill up vacant teaching positions of the university. All Deans/Directors shall submit their details of vacant posts to the CPO.
(Action: All Deans/Directors/CPO)
- 5- Financial issue related to the wages of the contractual workers to be sorted out soon.
(Action: Comptroller/ADLW)
- 6- Hon'ble Vice-Chancellor desired that all the Deans/Directors should prepare a plan to make their unit self-sustainable.
(Action: All Deans/Directors)
- 7- All Deans were asked to prepare a proposal for having teaching personnel's against vacant teaching positions and send it to comptroller.
(Action: All Deans/Directors/Comptroller)
