The application fee once paid will not be refunded in any case. Applications not on prescribed format or incomplete or received after due date will not be accepted. Service Candidates should send their application through proper channel. However, advance copy should reach before the closing date otherwise such application received through proper channel after closing date shall not be entertained. The applications through proper channel will be accepted up to **27.08.2024** in case advance copy of application is received on or before closing date of application. The minimum eligibility qualifications of candidate will be determined on the closing date of receipt of applications.

The University reserves the right to fill or not to fill or to increase or decrease the number of any post(s) so advertised. All disputes are subject to District Udham Singh Nagar (Uttarakhand State) jurisdiction.

Pay-scales: Deans: As per 7th Pay Commission.

Retirement age and benefits will be as per Government (Uttarakhand) orders from time to time and adopted by the University. Presently the age of retirement of Deans of faculties is 65 years. Candidates must have minimum two and half (2½) years of service period left on 10.08.2024.

Fifteen years of teaching experience of degree classes/research/extension/industry as evident by publications/ professional experience of which at least 5 years should be in the capacity of the Professor or equivalent or working on senior position in industry. 3.
