## General Instructions for first round of online counselling: 2021-22

Candidates should read the following instructions carefully before filling the choices:

- 1. Choices once filled for any round of counselling cannot be changed at any stage during this round of counselling.
- 2. Seats will be allotted in order of preference of choices filled by the candidates subject to the availability.
- 3. Seat allotted to the candidate will not be changed under any circumstances.
- 4. Each candidate willing to participate in any round of counselling will pay a non-refundable counselling fee of Rs. 500 (For MCA Rs. 2000).
- 5. Seat allotted in first round of counselling will be not be upgraded automatically in the second round. The candidates will participate in next round (s) only by filling the choices and paying counselling fee of Rs. 500 (For MCA Rs. 2000). This process will continue if further rounds of counselling are carried out due to availability of seats.
- 6. If a candidate accepts the seat allotted to him/her in first round, deposits applicable university fee and fills choices for the second round, then other seat of his/her choice in the second round will be allotted subject to availability after cancelling the seat allotted in the first round and no claim for the seat allotted in the first round will be entertained under any circumstances.
- 7. After allotment of seat, the candidates will have to pay total university fee as per details given below (The fee includes food advance of Rs. 20000 per semester):

Besides the university semester fee, programme fee per annum for self financing programme(s) will also be paid:

(a) B.Tech. Food Tech. - Rs.100000

(b) MCA - Rs. 65000

(c) Ph.D. Management - Rs. 50000

- 8. If a candidate fails to pay the required fee within stipulated time after allotment of seat, then the seat allotted to him/her will automatically be cancelled and will go to next round of counselling.
- 8. If a candidate leaves the seat allotted to him/her after depositing the applicable university fee, then the seat will be cancelled and will go to next round of counselling. The fee deposited by the candidate will be refunded as per university rules.
- 9. If a candidate deposits applicable university fee against a seat allotted in the first round of counselling and his/her seat is upgraded/retained in the second round as per choices filled, then the fee deposited will be adjusted for the seat allotted in the second round and balance payment, if any, will only be paid by the candidate. If the fee deposited by the candidate against the seat allotted in the first round is higher than the fee for the seat allotted in the second round, then the excess fee will be adjusted by the university against the fee or any other payment to be paid by the candidate in second semester. This process will continue if further rounds are conducted due to availability of seats.
- 10. Candidates are advised in their own interest to ensure that they fulfil eligibility criteria for admission to the courses for which they are filling their choices.

- 11. For admission to B.V.Sc. & A.H. programme, minimum age limit is 17 years for all candidates and maximum age limit is 25 years for general category and 30 years on or before 31.12.2021 for SC/ST/OBC categories.
- 12. For admission to B.Sc. (Hons.) Agri., B.Sc. (Hons.) Comm. Sc., B.F.Sc. and B.Tech. Food Tech. maximum age limit is 22 years for general and OBC categories and 25 years as on 31.12.2021 for SC/ST categories.
- 13. For M.Tech. programmes, the seats in the first round of counselling will be allotted to GATE qualified candidates on the basis of their GATE scores in the main branch of their choice. The seats in the second round may be allotted on the basis of B.Tech. Merit subject to availability after allotting seats to GATE qualified candidates. Other state candidates are not eligible for first round counselling in Agricultural Engineering Majors. They will be considered in second round of counselling subject to availability of seats.
- 14. The candidates who have completed their graduation with Agriculture will be eligible for M.Sc. Agricultural Statistics only when they have completed Intermediate with Mathematics as one of the subjects.
- 15. The conversion of seats of various categories in Ph.D. programmes only, if the seats remain vacant due to non-availability of eligible candidates in the first round of Ph.D. counselling, will be done in the second round to be conducted **in second semester** only as per provisions mentioned in the Prospectus (2021-2022) on page 25.
- 16. The candidates who fail to upload the mark sheet/PDC of the qualifying examination at the time of choice filling will not be allotted any seat of any programme, even if their names appear in the merit list on the basis of marks secured in Entrance Examination-2021 of the university.
- 17. The candidates who fail to upload Domicile/Category/Sub-category certificates at the time of choice filling, will not be allotted any seat of the category concerned and no claim after choice filling will be entertained in this regard.
