Schedule and Cut off Ranks for Masters' Counselling (2021-22) Spot Round

The spot round counselling for Masters programmes will be held in offline mode. For this round, all the candidates will fill choices online and upload documents on the portal only by depositing counselling fee of Rs. 500 during 21.12.2021 to 23.12.2021.

The candidates of different categories eligible for spot round of counselling for admissions to various Masters' and M.Tech. programmes during Session 2021-22 and the number of seats available are as follows: Duration of Choice Filling: 21.12.2021 to 23.12.2021 Date of seat allotment: 29.12.2021

The candidates who will be allotted some seat in the spot round will have to deposit fee online on the same day. Hence, they are advised to come here for counselling along with the arrangement of semester fee and all documents in original and two Photostat copies of each document for document verification. Besides two copies of application form will also be needed.

The following documents (two Photostat copies of each) along with the original documents (for verification) will be needed to submit for document verification on the same day.

- Seat allotment letter (will be issued here if allotted some seat)
- Receipt of counselling fee
- Receipt of programme fee (will be generated after deposition of fee if allotted seat)
- Self-Attested photocopies of High School Certificate and Marks-Sheet alongwith the originals.
- Self-Attested photocopies of Intermediate Certificate and Marks-Sheet alongwith the originals.
- Self-Attested photocopies of Marks-Sheet and Certificate of any other higher degree qualifications that he/she may possess alongwith the originals.
- Domicile Certificate of the State issued by the competent authority.
- Category (OBC/SC/ST/EWS) certificate
- Character and Conduct Certificate in original from the Head of the Institution last attended.
- Five-passport size photographs with name and ICAR Exam. Roll Number written on the back.
- A Gap Certificate accounting for discontinuity of more than three months after leaving the Institution attended. (Those employed should bring certificate from employer, others should produce a sworn affidavit duly notarized on stamp paper of Rs.10/- + Notary stamps Rs.10/- (total value Rs.20/).
- The Migration/Transfer Certificate in original to be submitted within three months of the admission.
- On the directives of the Hon'ble Supreme Court an affidavit duly signed by the candidate and his/her parents/guardian for non-participation in ragging on a non-judicial stamp paper of Rs. 10.00 duly notarized
- Medical fitness certificate from a Government Medical Officer

Note: 1. The seat will be allotted to those candidates only who produce the final year mark sheet/PDC at the time of spot counselling.

2. The number of seats may increase or decrease at the time of allotment.

3. If any candidate fails to produce valid weightage certificate (not applicable in case of M.Tech. programmes), 2% marks given at the time of result declaration will be deducted and his/her rank will be revised accordingly before allotment of the seat. Further if a candidate belonging to any category does not produce the corresponding certificate, then he/she will not be given the benefit of that category.

4. Only those candidates for M.Tech. programmes will be entertained for counselling who have filled online application through the portal. The seats will be allotted first for those who have qualified GATE and after this, seats will be allotted on the basis of B.Tech. merit.

5. The candidates in their own interest are requested to check the number of seats available and eligibility for different programmes before filling choices, as there is no guarantee that they will get a seat of their choice in spot allotment.

6. Allotment of seats will be made on the prescribed days in the office of undersigned and candidates will have to personally appear in spot counselling.
