ENTRANCE EXAMINATION RESULT FOR DIPLOMA COURSE IN VETERINARY
PHARMACY PROGRAMME (DCVP) 2021-22

On the basis of the Entrance Examination conducted by the University on Sunday, the Feb. 20, 2022, following is the merit list of candidates for admission to **Diploma Course in Veterinary Pharmacy**. In the event of two or more candidates securing equal marks, the merit is decided on the basis of marks secured in Chemistry then Biology, Physics and thereafter in the qualifying examination. In the event of tie again, a candidate with higher in age would be rated higher in merit.

The reservations in respect of the OBC, S.C. and S.T. categories shall be admissible as per the policy approved by the Government of Uttarakhand.

The candidates shall be called for Admission in order of merit and offered the programme as per number of seats available on the date and time. **The candidates are advised to see the University website www.gbpuat.ac.in for the date of admission.** Students will have to deposit the University fee and copies of the documents (specified in the Prospectus) during the admission. The admission will stop at the moment, the seats are filled up in **DCVP** programme.

The University reserves the right to cancel the selection/admission of any candidate included in this list, if it is found that his/her name has been included either due to an oversight/error on the part of the Controller of Examination or due to wrong information furnished by the candidate or on any reasons which in the opinion of the Vice-Chancellor renders the candidate unfit for admission to the University.
