1. Lifetime Achievement Award 2025

The Lifetime Achievement Award is the most prestigious to honor an individual who has reached the pinnacle of his/her career and made significant professional contributions over a sustained period of time. These contributions may be a new innovation, new knowledge, a new product or ways to improve professional practices and its use by the society. Importantly, the specific accomplishments should be truly extraordinary, widely recognized, and of positive and lasting quality.

Eligibility: The life Time Achievement Award is to recognize as alumnus who: (i) has an established record of distinguished for 25 years or more having age 60 or more than 60 years (ii) made a lasting contribution to his/her professional area and earned respect of peers (iii) exhibited leadership and provided inspiration to others in the sector (iv) well recognized for professional contribution at state, national and international level (v) Person once awarded will not be consider second time.

Nomination Format:

- a. Cover letter from the nominator summarizing the nominee's qualifications.
- b. Resume (CV) including ID No., Admission Batch, College, Contacts etc. Detailing education, appointments, activities, membership, awards and honours, and other relevant data.
- c. Summary of contributions to advancement of the profession, contributions leadership/service to local, state, national and international levels.
- d. Two letters of support with reflections on the nominee's contributions from individuals outside of the nominee's home institution.

The nominators should be an active member of the University Faculty or an alumnus of the University.
