BACKGROUND

Despite producing a wide variety of fruits, vegetables, ornamentals, spices, plantation and medicinal plants and standing second in world production of fruits and vegetables, India is losing 30-40% of their perishable horticultural produce immediately after harvesting. These post harvest losses begin in the field and travel along procurement chain and entire marketing channel and mainly caused due to mishandling of produce, improper storage and transportation facilities, poor marketing channels and seasonal gluts of produce. Consequently, farmers do not get remunerative returns due to price fluctuation in market which results in farmer's frustrations and suicides. Despite so much production only about 2.2% of the total horticultural produce is processed in India. The integrated approach from harvesting to delivery into the hands of consumer, if properly handled, can add value to fresh produce in the market. Adoption of appropriate post harvest management strategies will increase the shelf life and availability of horticultural produce throughout the year and helps to assure greater food and nutritional security, generate more employment opportunities and better returns to producer. Enough attention has been paid at the pre-harvest management of horticultural crops for boosting the level of production, but post-harvest management, value addition and processing issues have not been addressed adequately. Therefore, there is an urgent need to apply adequate attention for post harvest handling of horticultural produce. Hence this training is being organized with the following objectives.

- 1. To provide knowledge on recent advances in postharvest handling of horticultural crops.
- 2. To equip trainees on preservation and processing of different horticultural produce.

ABOUT THE INSTITUTE

G.B Pant University of Agriculture & Technology is the premier State Agricultural University for research and higher education in agricultural sciences. University was established in 1960 as the first agricultural university of India with the name 'UP Agricultural University' and later on rechristened as Govind Ballabh Pant University of Agriculture and Technology.
